

Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to 40.4 tCO₂e by 2029. This is a reduction of 23.8 %

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2024 baseline and the measures will be in effect when performing the contract.

- Smart meter installed
- Changed to fully LED lighting
- Recycling cardboard
- Reuse cardboard by supplier - collected by supplier

Future Carbon Reduction Initiatives

In the future we hope to implement further measures such as:

- Reduce company vehicle mileage by implementing additional planning and preparation procedures to mitigate inefficient route planning and the need for unforeseen return visits
- Consider replacing company vehicles with hybrid or electric vehicles at the end of vehicle lifespan
- Replace existing fan heaters with more efficient electric heaters
- Install PIR sensor to sewing room and kitchen light & educate and encourage staff to use cup measurements on kettle
- Investigate switching to 100% renewable energy
- Reduce upstream transportation emissions through bulk ordering of fabric and less frequent top-up orders
- Find fabric recycling facility for waste fabric instead of landfill
- Reduce emissions from commuting by investigating and considering implementing Electric Vehicle Salary Sacrifice & Bike to Work Schemes
